General system tourist railroad - A tourist, scenic, historic or excursion passenger operation which runs on tracks used for commercial freight service, or intercity or commuter passenger service. Typically, a "general system" tourist railroad has this status because it is also a short line freight railroad, or operates over trackage used by a short line freight railroad.

Non-general system / non-insular tourist railroad - A tourist, scenic, historic or excursion passenger rail operation which:

- 1. Does NOT operate on general railroad system trackage AND
- 2. Has ONE OR MORE of the following characteristics:
 - > An active public highway-rail crossing,
 - > An active grade crossing with another railroad,
 - > A bridge over a public road or waters used for commercial navigation, or
 - > A common corridor with another railroad (i.e. its operation are within 30 feet of those of any railroad)

Most non-general system tourist railroads are "non-insular" (typically because of one or more public grade crossings)

Non-general system / insular tourist railroad – A tourist, scenic, historic or excursion passenger rail operation (like an amusement park railroad) which:

- 1. Does NOT operate on general railroad system trackage, AND
- 2. Does NOT have ANY of the characteristics of a "non-insular" operation described in '2' above.
